Please complete the request form on the website providing all of the requested information and tick the tick box confirming that you have read and accepted the terms and conditions of this Agreement. We reserve the right to amend these terms and conditions from time to time without notice to you. The amended terms and conditions will be effective from the date it is posted on the website.

- Organisations information will be utilised to provide updates to partners on the Active Together Movement , support the development of Active Together Movement, demonstrate the impact of the Active Together Movement and in other suitable forms linked the Active Together Movement. You agree to being contacted by Leicester-Shire & Rutland Sport in relation to the Active Together Movement.
- Organisations agree to be referenced on the Leicester-Shire & Rutland Sport website as supporters of the Active Together Movement.
- The Active Together Assets can be downloaded by you from the Website, with you able to access the generic assets but also any specific assets created for your organisation.
- You are not permitted to use those assets created specifically for another organisation.
